## B. PROCLAMATION 2016-04: National Public Health Week, April 4 - April 8, 2016 - Healthiest Nation 2030:

-Public Health is the science of protecting and improving families and communities through the promotion of healthy lifestyles, research for disease and injury prevention and detection and control of infectious diseases. Recognizing National Public Health Week allows for a focused opportunity for the public to learn about the public health concerns and celebrate local success stories. Shelly Schneider, Health Director, and Janel Rose, Health Educator, will discuss the community goals of healthy eating, active living, reduced poverty, improved access to health care and mental health care that will make this community a healthier place to live.

Shelly Schneider, Health Director, said the top 10 greatest public health achievements in the 20th century as reported by the CDC are: immunizations, motor vehicle safety, workplace safety, control infectious diseases, a decline in deaths from heart disease and stroke by preventative measures, safer and healthier foods, healthier mothers and babies, family planning, fluoridation of drinking water and recognizing tobacco as a health hazard. Schneider read the proclamation and asked the Commissioners to adopt.

Commissioner Schartz moved to adopt Proclamation 2016-04, National Public Health Week. Commissioner Schremmer seconded the motion. All voted aye. Motion passed.

#### C. INFRASTRUCTURE REPAIR: Agreement for Emergency Relief Federal-Aid Road Construction, Project No. 5 C-4817-01/02/03/04/05/06/07:

-Barton County experienced damages on certain roads and bridges as a result of the thunderstorms. heavy rains and flash flooding in Spring, 2015. On June 15, 2015, the County Commission declared a state of local disaster and was included in a Federal Disaster Declaration on July 20, 2015. Some of the damaged infrastructure was originally constructed with Federal Aid monies. As such, it cannot be submitted for Public Assistance money under the Federal Disaster Declaration. Consequently a separate damage assessment must be made through the Kansas Department of Transportation (KDOT) for assistance. Barton County applied for those funds and has now received an agreement from KDOT for the approved Emergency Relief Repair.

Dale Phillips, Road and Bridge Director, said the total estimate for the project was \$133,635.52 with the Federal share at \$90,974.57. Phillips said they will pay 80% of the project costs.

D. ROAD AND BRIDGE: Asphalt Mix Bids 2016:

-The Road and Bridge Department accepted bids until 2:00 p.m., March 16, 2016, for the 2016 Asphalt Mix Program. The bid specified approximately 25,000 tons of cold mix asphalt material, with the County furnishing all aggregate and asphalt oil. Using County specifications, the contractor will be required to mix asphalt at the County pit on South Washington, Great Bend. Venture Corporation provided the only bid at \$7.43 per ton. Monies were included in the 2016 Budget for this anticipated expense.

Dale Phillips, Road and Bridge Director, said the Venture Corporation's bid was the same as last year and noted the project will start the latter part of May and be completed the first week of June. Phillips said the total product will probably be gone by mid-July. Phillips said they completed 42 miles of strip patching and overlay with last year's supply.

Commissioner Schartz moved to approve the Asphalt Mix Bids (2016) for up to 25,000 tons of cold mix asphalt material from Venture Corporation for \$7.43 per ton. Cost to be paid from the Road and Bridge Fund, Contract Construction line, 002-92-6250.

Commissioner Schremmer seconded the motion.

All voted aye. Motion passed.

E. 2016 TAX SALE: Filing:

-On March 18, 2016, the 2016 Tax Sale petition was filed with the Clerk of the District Court. Subsequent to the filing, the County, where possible, is mailing parties to the sale a summons, a copy of the petition and the corresponding limited Certificate of Title by certified mail. As necessary, other parties will be notified via publication. To avoid having a property sold at auction, owners must pay all taxes from, generally, 2012 forward and a redemption fee of \$170.00.

Richard Boeckman, County Counselor/Administrator, said they filed on 104 tracts and noted this is a smaller tax sale this year. Boeckman thanked Diana Watson for all of her work on the sale and also thanked Kevin Wondra for allowing Teresa Cass and Tami Johns to help. Boeckman said he filed summons with the Clerk of the District Court prior to the meeting.
