ITEM B. FAÇADE IMPROVEMENT GRANT: Claflin Main Street Corridor Project – Bailey's Food Bin, Inc.; Cheyenne Bottoms Armory LLC; Vickie Oeser, Quilting by Vickie; and CiJi Folk, Squeegy's Bar and Grill:

-Matt Patzner, County Administrator, will provide details. The Claflin Main Street Corridor Project businesses, including Bailey's Food Bin, Inc.; Cheyenne Bottoms Armory LLC; Vickie Oeser, Quilting by Vickie; and CiJi Folk, Squeegy's Bar and Grill, have applied for \$32,203.46 in grant funding to improve certain buildings located on the Main Street Corridor in Claflin, Kansas. It is anticipated that the City of Claflin will approve the \$42,937.94 project which includes a \$10,734.48 match by the applicants, equaling 25% of the project. Troy Bailey, Ryan Oeser, Vickie Oeser and CiJi Folk are contacts for this project.

ITEM C. FAÇADE IMPROVEMENT GRANT: Caitlyn Meitner, Brick & Blossom, Hoisington:

-Mr. Patzner will provide details. Caitlyn Meitner, on behalf of Brick & Blossom, 104 N Main, Hoisington, Kansas, has applied for \$13,552.70 in grant funding. The City of Hoisington has approved this \$18,030.26 project which includes a \$4,477.56 match by the applicant which equates to 25% of the project.

ITEM D. 20th JUDICIAL DISTRICT JUVENILE SERVICES: Fiscal Year 2025 Year-End Outcomes:

-Marissa Woodmansee, Juvenile Services Director, will provide details. The Kansas Department of Corrections provides grants to Kansas Counties to develop and maintain a range of programs for juvenile offenders. As a part of that grant funding, Juvenile Services is expected to meet certain outcomes as delineated in service provisions. The Year-End Outcomes Report sets out the results at the fiscal year's close and requires the review and approval of the Barton County Commissioners as the Administrative County for the District.
