Governor Laura Kelly, in collaboration with the Kansas Department of Corrections (KDOC), initiated the juvenile justice-focused Stepping Up initiative to address the prevalence of behavioral health needs among youth in Kansas. The program's aim is to reduce the use of detention and increase connections to improve outcomes for youth and families and enhance community safety.
