- A. RESOLUTION 2016-20: Resolution to Approve the Proposed Extension District:

-The Barton County / KSU Extension Council has explored an option to join the Ellis County Extension Council in forming an extension district. Prior to approving any agreement of a proposed district, the Barton County Commissioners are required to provide certain notice. While it is the intent of the Commission to approve an agreement to permit the extension district, the Commission recognizes that is possible that the Commissioners or voters in one of these other counties may disapprove that County's joining the district. Further, a petition may be filed in opposition. The Extension Council will join in a discussion of this Resolution.

# B. BARTON COUNTY COMMUNITY DEVELOPMENT ADVISORY BOARD: Board Appointments:

-The County recently sought applicants for the Barton County Community Development Advisory Board (BCCDAB). The BCCDAB advises the Commission on economic and community development matters, monitors the progress of the Barton County Strategic Plan and makes suggestions to the Commissioners concerning the advancement and realization of the plan goals.

# C. SOLID WASTE: Replacement of a Caterpillar 287 Compact Track Loader:

-The Landfill operates a Caterpillar 287 compact track loader at its Municipal Solid Waste Landfill to spread rock, mow ditches, recycle mattresses, remove snow and complete various other tasks. This loader is a 2003 year model, with over 3000 hours, and the manufacturer does not offer a rebuild program. Currently, the machine is in need of an undercarriage overhaul and new tracks at a cost of approximately \$15,000. Landfill management has obtained pricing from qualified vendors for a replacement track loader. Phil Hathcock, Solid Waste Director, will discuss details.
