BUDGET HEARING: 2021 Operating Budget:

-Fire District Officials were asked to submit a preliminary budget request for the 2021 Operating Year. It ow presented to receive public comment.

Matt Patzner, Finance Officer, said this budget has a mill decrease of just under .2 mills. The district had a valuation decrease of 1.1 million and increased cash carry-forward in the beginning of 2020 of approximately \$17,000.

Commissioner Schartz asked how the mill levy went down if the value also decreased. Patzner said they had increased cash carry-forward.

Doug Hubbard, Claflin Fire Chief, said even with the .178 decrease it will still bring in an additional \$8,000. Hubbard said he did not want to decrease the budget because he would like to transfer to reserves at year-end to eventually upgrade of the radio system.

Commissioner Daily asked what the radio expense would be. Hubbard said approximately \$70,000. Daily asked if there was enough money on hand. Hubbard said not yet but are planning another transfer at year-end and are also looking at available grants.

Commissioner Schremmer asked how much they are short. Hubbard said they have about \$70,000 right now but does not want to completely deplete reserves. Hubbard said they would like another tower so they could use the radios inside buildings and noted mobile radios work fine but have trouble when working inside buildings or on the fringes.

Commissioner Daily asked if they have given any thought to mobile radio repeaters. Hubbard said yes, but they are very expensive and would need more than one. Hubbard said they are saving funds for radios now where they had been saving for trucks for the past several years. The last truck has been put in a service.

Commissioner Schremmer said what about the cave for people to go into during storms? Hubbard said occasionally you can tell people have gone in there. It is always unlocked. Hubbard said it is an above-ground shelter and noted they sweep it out periodically.
