#### III. NEW BUSINESS:

A. 2019 Claflin Fire District #1 Building Roof Repairs Proposal:

-Bids were accepted for Building Roof Repairs for Fire District No. 1 until October 11, 2019. Work included the repair and / or replacement of the roof, along with trim, guttering and down spouts.

Doug Hubbard, Fire Chief, said the roof was severely damaged by a hailstorm last June. Hubbard reported the insurance company issued a check for \$59,512.90.

Commissioner Schartz asked how much the deductible was. Hubbard said \$500 deductible.

Hubbard said the following bids were received:

D & E Smith Construction for \$50,198.22

Steel Builders Construction for \$49,500.00

Hubbard said Steel Builders built the original building in 1998 and suggested accepting the bid from Steel Builders.

Commissioner Schremmer moved to accept the low bid of \$49,500.00 from Steel Builders Construction, Inc. for the Building Roof Repairs Proposal. Price to be paid from the Fire District No. 1 Fund, Building & Fixed Equipment Line, 055-50-6325.

commissioner Schartz asked how much of the insurance claim would be left over. Hubbard said approximately \$10,000 and noted they were electing not to replace the doors, as the damage was only cosmetic. Hubbard said they should be able to transfer the remaining money into the reserve or special equipment fund at year-end.

**IV. OTHER BUSINESS:** 

- Doug Hubbard: Three years ago, the Ellsworth prison rebuilt one of the military trucks. The Fire Department is now working on a second truck. Joe Schwartz ran the maintenance operation at the prison and now has his own shop in Kanopolis. They have not heard back from any of the other vendors they contacted other than Schwartz. The work done at the prison cost about \$2,000 for paint and supplies. Now that Schwartz has his own shop, he is charging \$4,500. He will try to get more bids. Schwartz could have the work done in December possibly. Approximate 3-week project. Might do half the work in 2019 and the other half in 2020. The radio, lights and sirens were all moved over from a different truck.
- Comm Davis: This is part of what Workforce does, helping someone to transition to employment.
