Barb Esfeld, County Appraiser, said this is the airport exemption and noted the storing of the turbines changed their exemption status. Esfeld said she thought this would come back as partly exempt and partly non-exempt. The airport is a little different from the normal exemption; the definition for that area is "primarily" exempt. The Board of Tax Appeals did not use the mixed-use exemption, but made them entirely exempt for 2018.

Zimmerman said these properties were included in the value when mill levies were set. This will result in a shortage to the entities, as they believed they were going to receive that money.

Schartz asked if the entities had been notified. Zimmerman said they would be notified later today.

Chartz asked what portion is Barton County's portion. Zimmerman calculated approximately \$80,000.

WHEREAS, sexual violence is a widespread, preventable, public health problem in Kansas; and

- WHEREAS, the statistics do not represent the true incidence and prevalence of sexual violence for multiple reasons, including not all victims report the crime to law enforcement; and that sexual violence is often a tactic of domestic violence, so sexual violence may not be reported as the primary form of abuse and victimization by law enforcement although the victim has experienced sexual violence along with another kind of primary abuse; and
- WHEREAS, the Family Crisis Center, Inc. is Barton County's local victim's advocacy and services program for people in this community who have had sexual and/or domestic violence inflicted upon them.
- NOW, THEREFORE, BE IT PROCLAIMED by the Board of County Commissioners of Barton County, Kansas, that the month of April, 2019, is named as Sexual Assault Awareness Month; and
- **FURTHER,** the Commission urges all citizens to become familiar with community resources and common reactions to sexual assault. As a community, it is vital to understand the survivor's experiences and the process of recovery.
