Levi Morris said his office has been working with law enforcement to work with an individual to obtain a blood draw when they refuse a breath test. Morris said he is hopeful they take fewer cases to jury trial for the lack of a blood draw.

Commissioner Daily asked if no refusal means that on a roadside when an officer says, you need to take a breath test, they can refuse it. Morris said the law implies their consent. An officer should not tell the person that they can't refuse to take the test. If the officer has probable cause that the person was driving under the influence, they could obtain a warrant for the blood test.

Daily asked if they are still disallowing the horizontal gaze nystagmus. Morris said as of today, Kansas Supreme Court has not changed the long-standing rule that HGN is currently inadmissible.

Schartz asked if someone refuses the breath test where do you do the blood draw. Morris said most likely, they are detained and taken to the hospital. Schartz asked if that means the person has to pay for that. Morris said those costs are most likely paid by law enforcement and then added as costs at the jury trial. Morris said he is fairly sure it will shake out and pay dividends in the future in the reduction of trials.

Davis asked if the plea deals from what happened at the fair a year ago would actually save the county money in the long run. Morris said it increases the chance they won't go over budget. It won't necessarily save us money. Morris said four of the five suspects have plead and Chaz Stephens has also plead. Morris noted expert testimony is extremely expensive.
