Barry McManaman, County Engineer, made the placement determination as sight distance is limited by trees. The Commission will be asked to consider adoption of the Resolution.

Barry McManaman, County Engineer, said he was approached by a citizen in the Dubuque area who asked that the intersection be looked at due to limited site distance. McManaman showed a slide show of the intersection and recommended the placement of a single stop sign.

Commissioner Schremmer said there is a lot of lake traffic that travels through there.

Commissioner Schremmer moved to adopt Resolution 2019-10, Placement of a Stop Sign at the Intersection of NE 230 Road and NE 90 Avenue, and that's in Beaver Township. Commissioner Daily seconded the motion.

Commissioner Schartz asked if this is a shared road with Russell County. McManaman said yes and that Barton County maintains the road.

D. COUNTY WORKS: Vehicle Replacement:

-The County Works Department has researched options related to the replacement of a 2007 Chevy 2500HD. Specifications for replacement included a four-wheel drive truck with a crew cab and tow package. The bid best meeting the needs of the department was provided by Marmies, a 2019 Ram 1500 Classic Big Horn Crew Cab 4X4 at a cost of \$35,699.00.

Darren Williams, County Works Director, said he received the two following bids from Marmies:

2019 Ram 1500 Classic Big Horn Crew Cab 4x4

\$35,699

2019 Ford F150 4x4 Crew Cab

\$38,505

Schartz asked if he sought bids from everyone in the county. Williams said yes and that he received a bid later from Manweiler that was higher.

Commissioner Davis moved to approve the purchase of a 2019 Ram Classic Big Horn Crew Cab 4X4, or like vehicle, from Marmie Motors Inc. for a total of \$35,699.00. Cost to be paid from the Equipment Replacement Fund, Equipment Replacement – Road and Bridge Line, 072-00-6485. The current vehicle, a 2007 Chevy 2500HD, is to be sold by sealed bid or at public auction at a later date. Commissioner Daily seconded the motion.

E. COURTHOUSE EXTERIOR MAINTENANCE: Mid Continental Restoration – Project Update: -The exterior of the Courthouse is currently being cleaned, resealed and painted by Mid Continental Restoration.

Phil Hathcock, County Administrator, introduced Johnny Perez, Jerry Rich and Jed Perez from Mid Continental Restoration. Hathcock said they have been excellent to work with and noted Mid Continent worked thru the night a time or two when the daytime temperatures soared above 100 degrees.

Johnny Perez said as of right now they have applied approximately 325 gallons of paint and estimate it will take 350-400 gallons before the job is complete. Perez mentioned he painted the courthouse last time in 1984. Perez said they are using a good Sherwin William product and explained it actually turns into a rubber-based product.

RESOLUTION 2019-10

PLACEMENT OF A STOP SIGN At the Intersection of NE 230 Road and NE 90 Avenue, Beaver Township

- WHEREAS, the Board of County Commissioners of Barton County, Kansas, has jurisdiction to place and maintain traffic control devices upon roadways under their jurisdiction as they may deem necessary; and
- WHEREAS, it is deemed in the public interest to control and regulate traffic at the intersection of various Barton County roads within this jurisdiction.
- NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Barton County, Kansas, that the following signage should be placed at the following intersection:

The intersection of NE 230 Road and NE 90 Avenue being located in Beaver Township, Barton County, Kansas. One stop sign shall be placed on the west side of the intersection. Signage shall be placed so that eastbound traffic on NE 230 Road will be required to come to a stop before proceeding.

- BE IT FURTHER RESOLVED that all sign installation shall be made and maintained by the Board of Barton County Commissioners in accordance with the "Manual on Uniform Traffic Control Devices" as set forth by the Federal Highway Administration and adopted by the Kansas Department of Transportation; and
- FURTHER that should this Resolution be in conflict with any other resolution of the Board of County Commissioners of Barton County, Kansas, that only the conflicting part of the previous resolution, and not the previous resolution in total, shall be declared void and ineffective; and
- **FURTHER**, the described stop shall become effective after the publication of this Resolution in the official County newspaper and upon the installation of appropriate signage.
