Winkelman said Dr. Hatesohl emailed his resignation effective November 1, 2020 and said it was a pleasure working with Karen Winkelman during these challenging times. Hatesohl also indicated his resignation as District Coroner and also thanked the Sheriff's Department in addition to the local police departments.

## **RESOLUTION 2020-04: A Resolution Appointing the Barton County Local Health Officer, Public Health Director and Medical Consultant and Rescinding Resolution 2020-03, Same, Adopted July 2, 2020:**

-Pursuant to KSA 65-201, and any revisions thereof, the Barton County Commissioners act as the Board of Health for Barton County, Kansas. Said Board is empowered to appoint a person licensed to practice medicine and surgery, preference being given to persons who have training in public health, who shall serve in an advisory capacity to the County Board of Health. It is suggested that Dr. Jonathan Pike be appointed as a paid medical consultant to the Local Health Officer at this time.

Karen Winkelman, Public Health Director, said she has visited with Dr. Pike and has already shared information.

Commissioner Daily thanked Dr. Pike for his willingness to work with the Health Department in that capacity.

Karen Winkelman read the resolution.

Commissioner Schartz moved to adopt Resolution 2020-04, A Resolution Appointing the Barton County Local Health Officer, Public Health Director and Medical Consultant and Rescinding Resolution 2020-03, Same, Adopted July 2, 2020.

Commissioner Davis seconded the motion.

Commissioner Schremmer thanked Ms. Winkelman for all of her hard work.

Dr. Pike thanked Karen and the Commissioners for the ability to serve in this capacity. Pike said we have been in perilous times the past 6-8 months and said it takes time for the country to gather the information to understand the long term affects and courses of treatment. Pike said he appreciates the guidelines KDHE provides and also understands there are also socioeconomic and financial factors to consider. If there is a decision made to deviate from the KDHE or CDC guidelines, Pike said he feels that deviation would require a very specific plan with consultation from the education communities.




At 9:16 A.M. Commissioner Daily moved to close the Board of Health Meeting and move into the Regular Meeting of the Barton County Commission.

RESOLUTION 2020-04

**A Resolution Appointing the  
Barton County Local Health Officer, Public Health Director and Medical Consultant  
and Rescinding Resolution 2020-03, Same, Adopted July 2, 2020**

**WHEREAS**, pursuant to KSA 65-201, and any revisions thereof, the Barton County Commissioners act as the Board of Health for Barton County, Kansas. Said Board is empowered to appoint a person licensed to practice medicine and surgery, preference being given to persons who have training in public health, who shall serve in an advisory capacity to the County Board of Health and as the Local Health Officer; and

**WHEREAS**, said Board is also empowered to appoint a person licensed to practice medicine and surgery or person licensed to practice dentistry to act as a consultant to the Local Health Officer.

**NOW, THEREFOR BE IT RESOLVED**, by the Board of County Commissioners of Barton County, Kansas, that pursuant to KSA 65-201, Karen Winkelman was appointed and shall continue to act as the Local Health Officer and as the Public Health Director, serving at the pleasure of the Commission acting as the Board of Health; and


**FURTHER**, Dr. Jonathan Pike shall be appointed as a medical consultant to the Local Health Officer effective November 1, 2020; and

**FURTHER**, that the Medical Consultant shall be paid for services from the Public Health Fund and that rate shall be \$325.00 per month unless otherwise amended by the Board of Health; and

**FURTHER**, that Resolution 2020-03, A Resolution Appointing the Interim Barton County Local Health Officer and Medical Consultant and Rescinding Resolution 2020-03, Same, adopted July 2, 2020, is hereby rescinded.



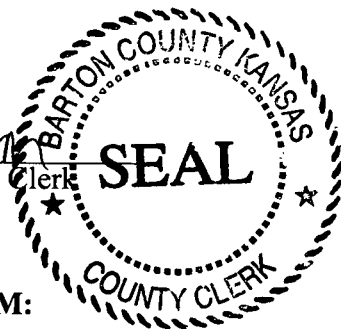


