F. COMMISSION: COVID-19 Award From HHS:

Health Department - Barton County was awarded a bonus payment from Phase 4 General Distribution and ARPA Rural Payment from the U.S. Department of Health and Human Services. Matt Patzner will provide details.

Matt Patzner, Director of Operations, said in September 2021, the U.S. Department of Health and Human Services announced an application for new funding available for healthcare providers affected by the COVID-19 pandemic. This included finding from the Coronavirus Aid, Relief, and Economic Security (CARES) Act; the Paycheck Protection Program (PPP) and Health Care Enhancement Act, the Coronavirus Response and Relief Supplemental Appropriations Act, and the American Rescue Plan Act. Barton County was awarded a base payment of \$17,877.53 on December 2, 2021. This was calculated as a percentage of expenses and revenues reported from July 1, 2020 to March 31,2021. Barton County was awarded a bonus payment of \$26,296.81 on December 16, 2021. Asked the commission to consider accepting the Phase 4 General Distribution.

Commissioner Schartz asked if there was any risk of having to pay back this money. Patzner said that was always something to consider but that was why they were diligent when following the guidelines for grant funding.

Commissioner Daily moved to accept the Phase 4 General Distribution and ARPA Rural Payment from the U.S. Department of Health and Human Services, in the amount of \$26,296.81, funded by the Coronavirus Aid, Relief, and Economic Security (CARES) Act; the Paycheck Protection Program (PPP) and Health Care Enhancement Act, the Coronavirus Response and Relief Supplemental Appropriations ^-t, and the American Rescue Plan Act (PL 117-002). Funds to be deposited in the HHS Grant Fund, Jeral Funds Received Line, 909-00-4286.

Commissioner Schartz seconded the motion.

G. SOLID WASTE: Repair of a Cat 826K Compactor:

-The Barton County Landfill owns and operates a Caterpillar 826K Compactor that is utilized daily to compact municipal solid waste at the landfill. The machine was damaged during a fire at the landfill in June of 2021. Due to the extent of the damage, the machine was transported to Foley Equipment in Salina and disassembled, inspected and repaired. Barton County has submitted an insurance claim for the fire damage and will be reimbursed upon approval of the invoice. Phil Hathcock, Solid Waste Director, will provide details.

Phil Hathcock, Solid Waste Director, said they received a bill from Foley for repairs in the amount of \$210,608.78. The insurance paid \$202,472.24 leaving approximately \$8,100.00 to be paid from the Solid Waste Fund. Insurance did not cover everything because they had some repairs made while Foley had the machine.

Commissioner Schartz asked if the machine was considered rebuilt. Hathcock said they had the machine rebuilt approximately 2 years ago. It was still under warranty so Foley went through it extensively and made sure that no damage from the fire would affect the warranty.

Commissioner Schartz asked if the warranty started over from this point. Hathcock said no, however there are some new parts with new warranties.

Commissioner Hutchinson noted the fires have cost the county and asked Hathcock to tell about measures being taken to mitigate the risk of fires in the future.

thcock said they purchased a fire truck to help with daytime fires. Installed a thermal camera that wifies himself and Dereck Hollingshead of high temperatures for faster response to potential fires after operating hours. Working with KDHE on a grant for more public awareness about disposal of lithium batteries.

Commissioner Krier moved to approve the repair cost of the Cat 826K Compactor by Foley Equipment. The total cost, \$210,608.78, to be paid from the Solid Waste Budget, Maintenance of Machinery and Equipment Line, 140-68-5460. Insurance proceeds, if any, to be deposited into the Solid Waste Fund. Commissioner Daily seconded the motion. All voted aye. Motion passed.

nmissioner Daily – no, they cannot.

Commissioner Krier – should the commission revisit the burn ban on a weekly basis.
