III. NEW BUSINESS:

A. RESOLUTION 2022-01: A Resolution Establishing a Regular Meeting Schedule for the County Commission and Rescinding Resolution 2021-15, Same, adopted August 9, 2021:

-KSA 19-206 authorizes the Commission to meet in regular session on such days and at such times each month as may be determined. Said meeting schedule is to be established through the adoption of a Resolution. At this time, Chairman James R. Daily will lead a discussion to determine if the Commission wishes to change meeting dates from Tuesday to another day of the week.

Commissioner Daily said that the meetings were changed from Mondays to Tuesdays in August 2021. This was to make it easier for Department Heads and the public to attend meetings. It has been suggested to change the meeting day to Wednesday at this time, still beginning at 9:00 A.M.

Commissioner Esfeld said she did not mind Wednesday but she would like to break for lunch so she could attend Kiwanis meetings. She had spoke with Dale Hogg and Ken Carpenter to be sure the change would work for them.

Commissioner Hutchinson asked that the change not take effect until January 19th as he has conflicts January 12th.

Dale Hogg, Great Bend Tribune, asked why the change for the meeting day.

mmissioner Daily said Patrick Hoffman, County Counselor, has a conflict on Tuesdays.

Hoffman thanked the commissioners for considering the change. He has an opportunity and felt it would benefit Barton County if he was able to do it.

Commissioner Hutchinson asked Hoffman if he was at liberty to give more information.

Hoffman said another county was considering him as their county counselor as well. He would change the focus of his practice to be more devoted to county counseling.

Commissioner Hutchinson said Hoffman had mentioned he would be more available to Barton County. Hoffman said yes, he will be restructuring to working with just the two counties.

Commissioner Schartz said they had all agreed that they value Hoffman enough to make a change.

Commissioner Krier asked Hoffman when the transition would take place. Hoffman said if the other county acts on it next week as indicated, it would be immediately.
