I. OPENING BUSINESS:

Commissioner Hutchinson called the meeting to order at 9:00 A.M.

Inufacturing Day. They plan to have more student tours this year as well as adding working adult tours. The college, high school and a class from Lincoln Elementary will tour. Tours will start the week of October 24th. Barfield said they will be doing a ribbon cutting and Chamber coffee for Barton Community College October 13th. They will be announcing new programs. Pints and Politics will be November 14th from 4:30 – 6:30.

Commissioner Prescott asked Barfield what manufacturing companies would be toured. Barfield said she had surveys out now for the companies to sign up.

B. FAÇADE IMPROVEMENT PROJECT: Request for Extended Deadline – Andrew Mingenback, The Landing:

-Mark Mingenback will provide details. In September, 2021, Andrew Mingenback was awarded a \$20,000.00 Façade Improvement Grant allocation for the property located at 2105 Forest, Great Bend. Since its inception, there have been supply line issues and historical considerations affected the project. The Commission will be asked to extend the deadline to June 30, 2023.

Mark Mingenback thanked the commissioners for establishing the program, the relationships created were very significant. Mingenback said they had challenges and delays with their project. There were significant changes to the façade from the original plan. They have submitted a historical tax credit application. Part 1 was being reviewed by the State Historical Society. The new illustration was designed Robert McLaughlin, the State Historical Architect, to reflect what the building looked like when it was lit in 1922. The original application for the Façade Improvement Grant was for 2105 Forest but would be incorporating 2107 Forest as well. In the event that the commission decided to do another round of Façade Improvement Grants, they would like to apply again for 2107 Forest.

Commissioner Hutchinson asked Mingenback if these were 2 separately taxed properties. Mingenback said they were separate at this time.

Mark Mingenback said they must have specific windows that are historically accurate. Andy Mingenback said that had also caused delays waiting for 6 or 7 people to approve them. Andy Mingenback said the tax credits would help out with the loft apartments and such.

Commissioner Krier asked about the wall of the chiropractor building. Andy Mingenback said they were designing the area with the park and the buildings for more murals and creating somewhat of an art district.

Commissioner Esfeld asked if there would be a restaurant. Andy Mingenback said there would be an area to accommodate a restaurant or possible an event space. Their intent was not to own a restaurant but possibly lease space for one.

Commissioner Hutchinson asked if they had qualified for the loft grant. Mark Mingenback said they had not yet applied but would qualify for them.

Commissioner Krier moved to extend the deadline for Andrew Mingenback, The Landing, 2105 Forest, Great Bend, Kansas, to June 30, 2023.

Commissioner Prescott seconded the motion. Voted aye. Motion passed.
