Boxberger introduced Charity Muth, local SUD (Substance Use Disorder) provider and member of Rise Up.

Charity Muth said addiction is a brain disease, it is progressive and chronic and without treatment, is fatal. We can all do better at helping, advocating, educating, and connecting people with resources.

Brian Bellendir, County Sheriff, said the Asset Forfeiture and Surplus County Equipment sale last week and was done jointly with the City of Great Bend. Bellendir conducted the sale so the only expense to the county was for advertising. Gross proceeds were just over \$81,000. \$10,375 goes into the Sheriffs Office funds with \$34,626 will go into the General Fund. There was an abandoned Mercedes Benz that sold for \$21,000. That money could not go into the Sheriffs Asset Forfeiture line because he did not have a case it. Statute reads that surplus county property and abandoned vehicles go into the General Fund.

Commissioner Krier asked Bellendir if his fund rolls over to the General Fund at the end of the year. Bellendir said it does not and had to be used for non-budgetary items.
