#### III. NEW BUSINESS:

# A. COUNTY CLERK / ELECTION OFFICER: Presidential Preference Primary Election – March 19, 2024:

-Bev Schmeidler, County Clerk / Election Officer, will provide details. The State of Kansas will hold a Presidential Preference Primary Election on March 19, 2024. An act by the Kansas legislature is required for this election as it takes the responsibility from the Republican and Democratic parties in Kansas from conducting a caucus, and instead, has the state conduct a primary election. It is a "preference" primary because it is an election where the vote totals are given to a political party to allocate delegates to candidates at the national convention. This is not a primary where the voters selected the party candidate.

Bev Schmeidler, County Clerk, presented details and said today was the deadline to register to vote or to change voter registration if moved or changed name. Today was also the last day to request a mail ballot. The rules for this Presidential Preference Primary were a little different from other elections with the closing of registration and applying for a mail ballot. Schmeidler said they had been trying to get the word out since this was at a different time of the year for elections. It was historical in that this was only the third time to have such an election in the state of Kansas. The previous ones were in 1980 and 1992. In those years, there were already spring elections held for cities and schools and the Presidential Primary Election was added on to those. Since municipal elections were moved to the fall several years ago, voters were not accustomed to having an election in the spring.

Commissioner Zimmerman asked Schmeidler if they were using all the same voting locations. Schmeidler said, yes, all the same locations and staff at the locations since they were unsure of what kind of voter turnout to expect.

Commissioner Reif said some things he had heard that were confusing to voters was that this was not taking place of the primary election, this was a Presidential Preference Primary. Schmeidler said this election was for voters to inform the parties of their preferred candidate.

Commissioner Schlessiger asked Schmeidler who pays for this election. Schmeidler said they would be reimbursed by the state for direct expenses. Schmeidler said for voters to call the office with any questions.
