Locognized as the State Project Award Winner in the Wildlife Project. Beran said it was a huge undertaking for Kern to make it through local, regional and then state competition. Beran said they had some Summer Engagement Interns. This was the third year in a three-year grant from the Kansas Department of Education to address gaps in education. They were able to hire local ladies, Jayla Wyant and Camille Dolechek. Their sole job was education, and they were at the Ellinwood Public Library doing programming. There was also required curriculum they had to get through in a partnership with school and then throughout July, there would be some fun activities.

Beran said pre-fair events would begin Saturday. They will begin with fiber arts, clothing construction and fashion review judging in the morning. On Saturday afternoon there will be the dog show. There had been a few years without a dog handler but someone with experience recently moved to the community. The Business Breakfast will be held Thursday, next week, at the Fairgrounds. The following weekend will be Kid's Day Saturday and a sunrise service on Sunday. Round robin, the best of the best show men and show women, then begins. They have a small animal competition which was very unusual in the state and then large animal.

Commissioner Schlessiger said she supported 4-H and the Barton County Fair. This was the first time in eleven years that her family would not have an animal at the fair.

Commissioner Reif said it was good to hear about the increase in animals.

B. UPDATE: Memorandum of Understanding – Barton County and Great Bend Economic Development:

-Chris Komarek, Ellinwood City Administrator, will present details. In August, 2022, Mr. Komarek detailed that the City of Ellinwood is developing a water, sanitary sewer and storm sewer infrastructure ject. Included in the project are both the new hospital and new housing area. The Commission approved \$300,000.00 in financial support and directed the County Counselor to develop a Memorandum of Understanding reference the administration of the funding. The Memorandum of Understanding was adopted October 26, 2022. As the project will not be finished by the original end date, it is suggested that the completion date be extended to December 31, 2024.

Chris Komarek, Ellinwood City Administrator, said he was present to provide an update and request an extension as things had moved slower than was anticipated. The hospital should be moving in the next 3-4 weeks and be fully service by August 1st. The housing project got delayed last year. They had a Plan A for the sewer and storm water drainage system. They had to switch to Plan B, which would shrink the size of the development slightly and cost more money. Things changed again and they were able to go back to Plan A which would save some money and allow them to go from 9 lots to 14 or 15 lots. The engineer would be coming and hoped to have things going well this summer or early fall. Komarek said the downtown sidewalk project should start around August 1st near the Wolf Hotel. They plan to get bids in November or December, so the rest of Main Street will probably be a spring project.

Commissioner Zimmerman said she was thrilled they were able to go back to Plan A and have the additional lots.

Commissioner Schlessiger said she supported the extension and said Komarek's communication with the commission had been outstanding. She was excited for Ellinwood, new houses and new hospital.

Commissioner Reif said there were a lot of exciting things going on in Ellinwood.

Commissioner Hutchinson asked Komarek if he had seen any reduction in the costs of materials since 2. Komarek said not any reduction, prices had stayed pretty stable.
