**I. OPENING BUSINESS:**

# A. JUVENILE SERVICES: Out of State Travel – Community Anti-Drug Coalitions of America's Mid-Year Forum:

-Marissa Woodmansee, Juvenile Services Director, will provide details. In 2021, Juvenile Services received a Centers for Disease Control and Prevention Drug-Free Communities Support program grant. A component of this grant includes training with the National Coalition Academy (NCA), working in partnership with the Community Anti-Drug Coalitions of America (CADCA). The Commission will be asked to allow Tyler Morton, Juvenile Services, and Holly Bowyer, The Center for Counseling, a grant partner, to attend training in Chicago, Illinois. The event will be held July 15 through 18, 2024.

Marissa Woodmansee, Juvenile Services Director, said the travel was part of the grant. There were remaining funds from previous years that allowed the opportunity for more youth to attend the conference. Woodmansee said the first year, they took one youth. The second year, they took six youth. This year they were taking eight youth. This was an opportunity for youth to learn from prevention specialists across the country.

Commissioner Esfeld said youth who attended in the past years had said it was life changing. They were able to be a part of breaking the cycle.

Tyler Morton, Juvenile Services and Youth Crew, said it was a tremendous opportunity even for those who had already attended a conference. Of the eight going this year, three had previously attended. Morton said they would be driving to Chicago to save on travel expenses. Last year was in Dallas and

they stayed at an all-inclusive resort. There were 2,500 attendees, with 500 of them being youths and they came from all over the world.

Commissioner Esfeld said she looked forward to hearing about their experience.

Commissioner Zimmerman asked Morton how the youth were chosen. Morton said it was based on their attendance, leadership qualities, event participation and volunteer hours.

Commissioner Zimmerman asked how many youths there were to choose from. Morton said there were 10 applicants this year.

Woodmansee said taking the group last year had brought recognition to the State of Kansas and now would be hosting the YLINK Conference in June at Hoisington High School.

Commissioner Hutchinson asked if it was a statewide conference and would hotels be needed. Woodmansee said it was statewide. The keynote speaker for the conference held training last year that Morton and Jasmine Figueroa attended.

Commissioner Zimmerman moved to approve out-of-state travel for Tyler Morton, Juvenile Services, and Holly Bowyer, The Center for Counseling, to attend training in Chicago, Illinois.
