PUBLIC HEALTH: RFP – Automated External Defibrillators:

-Karen Winkelman, Public Health Director, will provide details. As a part of a federal grant process, the Barton County Health Department was required to seek competitive bids for the purchase of 15 Automated External Defibrillators (AEDs). It is suggested that the bid be awarded to McKesson.

Karen Winkelman, Public Health Director, said over the years, they had been able to use grant funding to purchase an AED here and there and place them in the community. There was one in the courthouse on the second floor and each Sheriff's Office Sargeant has one in their cars. An opportunity came for use of the Public Health Infrastructure Grant, with a larger sum of money. Winkelman said Misty Trudeau, Financial Officer at the Health Department, and herself explored options to reach more people in the community. The grant approved AED purchases and they were able to get some solid quotes and were going to be able to purchase 15 units. Winkelman had talked to the Police Chiefs in Claflin, Hoisington, Ellinwood and Great Bend and each of them were excited to be able to put those in the law enforcement vehicles. Winkelman said that in Great Bend, EMS response was quick but sometimes officers arrived first, and the smaller communities were volunteer services. Winkelman said that she would also like to place additional units in the courthouse on the first and third floors and a unit in the Central Kansas Community Corrections building.

Commissioner Zimmerman asked Winkelman about training and wondered if the ones already in place had been used often. Winkelman said she knew of an instance that a Sheriff's Officer came close to using one. The combination of the AED and CPR were vital. Winkelman said the AED's have visual aids and voice prompts, designed for anyone to use.

Commissioner Schlessiger said Winkelman had told them in the study session that these were the same as the EMT's used. Winkelman said she checked with the EMS departments in the county and with this nd, the leads were interchangeable. Winkelman said she also checked with each of the police chiefs, and local EMS staff trained them and kept them current.

Commissioner Zimmerman moved to award the RFP - Automated External Defibrillators to McKesson. Commissioner Hutchinson seconded the motion. All voted aye. Motion passed.

C. SHERIFF'S OFFICE: Contract for Secure Detention Services for Juveniles:

-Patrick Hoffman, County Counselor, will provide details. Reno County has submitted a holding agreement to Barton County for the secure detention of juveniles. Under the agreement, Reno County will hold juveniles at a cost of \$165.00 per day. Monies are regularly scheduled under the Juvenile Detention account of the General Fund for this purpose.

Patrick Hoffman, County Counselor, said this was a housekeeping item. It was an agreement between Barton County and Bob Johnson's Youth Center in Reno County. Occasionally, there were juveniles that could not be held in foster care and were awaiting court proceedings, that needed to be held somewhere. Hoffman said they had requested the formal agreement be signed to keep the current funding rate. It was a safe and secure place for the occasional instances each year to hold the juveniles.

Commissioner Hutchinson asked the Sheriff if he had any issues with it. Sheriff Bellendir said he did not have any issues and did not think we had had a formal agreement in the past.

Commissioner Reif moved to approve the Contract for Secure Detention Services for Juveniles with Reno County, Kansas.

Commissioner Esfeld seconded the motion.
