The Great Bend Bat Cats Baseball Club expands to 32 states and eight countries, bringing student athletes to the Al Burns Memorial Field in Great Bend, Kansas, to develop skills, gain exposure and pursue a dream of playing professional baseball. With an estimated 8,000 people attending free games throughout a typical home season, the team offers local support by participating in community and service opportunities, reinforcing the organization's commitment to giving back. The Commission will now be asked to adopt a Proclamation celebrating 10 years of commitment to youth and community.

Commissioner Esfeld said not only was it Bat Cat Day, but they were also celebrating 10 years. Commissioner Esfeld said it was her honor to recognize Coach Roger Ward and Assistant Coaches Zach Dobbins and Derek Pomeroy and the team as they celebrate another outstanding season. She said if you had never attended a game, you were missing out on some of the best, free entertainment our community had to offer. She said these talented athletes contribute so much to Great Bend. They volunteer in the community, bring excitement to the ballfield and attract parents, family members and friends who travel to support them. This benefited our local businesses as well as gave us a chance to share our hospitality. They were respectful, hardworking young men.

J summers, they came up short by one win to get to the World Series. Ward said the next two weeks were going to be a whirlwind, they needed to play good baseball and hopefully have a little luck on their side, but they were currently in first place.
